NOTICE: ALL ENTRANTS AGREE AS FOLLOWS:

Gulf Coast Horse Shows & Festival are held in compliance with all laws and regulations of the United States and the State of Florida and all exhibitors, trainers and owners are notified to comply therewith with special reference to the Horse Protection Act of 1970 as amended and to certify that every horse is eligible to be entered and is sound. The person signing this entry form is authorized to bind the exhibitors, trainers and owners stated in this entry form to the extent of this agreement. All exhibitors, trainers or an authorized agent must sign the entry blank or class sheet; if not, the entrant's entry into the ring as an exhibitor shall be construed as acceptance of this agreement and the HIO hired by the GCCC Association, Inc. and GCCC Association, Inc.'s (hereinafter referred to as the Association) rules. Association, its sponsors, agents or volunteers or the City of Panama City Beach, will not be responsible for any accident, theft, injury or loss of whatsoever kind. The person signing agrees in connection with any use by the undersigned of Frank Brown Park and surrounding premises such shall be at their sole risk and further agrees that no liability will arise out of any act or omission of the Association, or its servants, agents employees, sponsors or volunteers or from the act of third parties, and further hereby waives any and all claims and causes of action directly or indirectly resulting or arising therefrom and further agrees to hold GCCC Association Inc., and Frank Brown Park and Convention & Visitors Bureau of Panama City Beach, Bay County, Florida and Panama City Beach and all sponsors and volunteers harmless and indemnify them against all claims, causes of action of every nature that may arise by virtue or use of the above referred Frank Brown Park and surrounding premises and any action or non-action taken at the show grounds. All references to GCCC Association, Inc., shall be construed as that of the corporation, its directors, stockholders, and any volunteers, agents and/or employees, and/or sponsors of such entity including without limitation the City of Panama City Beach, the County of Bay County and Panama City Beach Convention and Visitors Bureau.

EVERY ENTRY AT THESE COMPETITIONS SHALL CONSTITUTE AN AGREEMENT AND AFFIRMATION THAT ALL PARTICIPANTS (WHICH INCLUDE WITHOUT LIMITATION, THE OWNER, LESSEE, TRAINER, MANAGER, AGENT, COACH, DRIVER, RIDER, HANDLER AND THE HORSE), FOR THEMSELVES, THEIR PRINCIPALS REPRESENTATIVES, EMPLOYEES AND AGENTS: (1)SHALL BE SUBJECT TO ALL STATE LAWS AND FEDERAL LAWS AND REGULATIONS DULY PROMULGATED EACH YEAR AND THE RULES OF THE ASSOCIATION; (2) REPRESENT THAT EVERY HORSE, RIDER, DRIVER AND HANDLER IS ELIGIBLE AS ENTERED; (3) AGREE TO BE BOUND BY THE RULES OF THE HIO AND GCCC ASSOCIATION, INC., AND OF THE SHOWS, AND WILL ACCEPT AS FINAL THE DECISION OF THE HEARING COMMITTEE ON ANY QUESTION ARISING UNDER SAID RULES, AND AGREE TO HOLD THE ASSOCIATION , THE CITY OF PANAMA CITY BEACH, BAY COUNTY FLORIDA, CONVENTION AND VISITORS BUREAU OF PANAMA CITY BEACH, FLORIDA, THEIR OFFICIALS, DIRECTORS, EMPLOYEES, AND VOLUNTEERS HARMLESS FOR ANY ACTION OR OMISSION TAKEN; (4)AGREE THAT AS A CONDITION OF ENTRY, THEY AUTHORIZE THE GCCC ASSOCIATION, INC.TO MARKET, TRANSFER, ASSIGN OR OTHERWISE MAKE USE OF ANY PHOTOGRAPHS, LIKENESSES, FILMS, BROADCASTS, CABLE CASTS, AUDIOTAPES OR VIDEOTAPES TAKEN OF THE HORSE(S) AND PARTICIPANT(S) WHILE ON THE GROUNDS, INCIDENT TO, OR IN TRANSIT BETWEEN THE STABLING FACILITY AND THE EVENTS SITE, IN ANY WAY THEY HIPOSEES IT FIT FOR THE PROMOTION, COVERAGE OR BENEFIT OF THE EVENTS, SPORT, OR THE HIO OR GCCC ASSOCIATION, INC. WITHOUT COMPENSATION TO ANY OF THEM SO LONG AS THE USE NEITHER JEOPARDIZES AMATEUR STATUS, AND THEREBY EXPRESSIVEY AND IRREVOCABLY WAIVE AND RELEASE ANY RIGHTS IN CONNECTION WITH SUCH USE, INCLUDING WITHOUT LIMITATION ANY CLAIM TO INVASION OF PRIVACY, RIGHT OF PUBLICITY, OR TO MISAPPROPRIATION; AND (5) AGREE THAT THEY PARTICIPATE VOLUNTARILY IN THE COMPETITIONS FULLY AWARE THAT HORSE SPORTS AND THE COMPETITIONS INVOLVE INHERENT DANGEROUS RISK OF SERIOUS INJURY OR DEATH AND BY PARTICIPATING THAT THEY EXPRESSLY ASSUME ANY AND ALL RISKS OF INJURY OR LOSS, AND THEY AGREE TO INDEMNIFY AND HOLD THE NHSC, GCCC ASSOCIATION, INC., PANAMA CITY BEACH, BAY COUNTY FLORIDA, THEIR SPONSORS, AGENTS, EMPLOYEES, AND VOLUNTEERS, THE COMPETITIONS AND THEIR OFFICIALS, DIRECTORS, STOCKHOLDERS, EMPLOYEES AND AGENTS HARMLESS FROM AND AGAINST ALL CLAIMS INCLUDING WITHOUT LIMITATION FOR ANY INJURY OR LOSS SUFFERED DURING OR IN CONNECTION WITH COMPETITIONS, OR USE OF THE PARK, WHETHER OR NOT SUCH CLAIM, INJURY OR LOSS RESULTED OR AROSE, DIRECTLY OR INDIRECTLY, FROM THE NEGLIGENT ACTS OR OMISSIONS OF SAID OFFICIALS, DIRECTORS, EMPLOYEES OR VOLUNTEERS OF GCCC ASSOCIATION, INC., PANAMA CITY BEACH AND/OR BAY COUNTY FLORIDA OR THE COMPETITIONS.
